This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other nonhazardous ingredients are also possible.

## Section 4 - First Aid Measures

### General Information:

## Section 6 - Accidental Release Measures

<b>Accidental release:</b>	Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as minimum, protective glasses and, preferably, goggles.
